WHEREAS, the Board of Supervisors of Worth County, Iowa, hereafter referred to as "the Board", believes the 342nd Street Bridge Replacement project, BROS-SWAP-C098(73)--SE-98, hereafter referred to as "the project" is in the best interest of Worth County, Iowa, and the residents there of.
