## RESOLUTION NO. 2022.11.15

Resolution to Declare Necessity and Establish an Urban Renewal Area, Pursuant to Section 403.4 of the Code of Iowa, and Approve Urban Renewal Plan Amendment for the Worth County Consolidated Urban Renewal Area

WHEREAS, as a preliminary step to exercising the authority conferred upon Iowa counties by Chapter 403 of the Code of Iowa (the "Urban Renewal Law") a county must adopt a resolution finding that one or more slums, blighted or economic development areas exist in the county and that the development of such area or areas is necessary in the interest of the public health, safety or welfare of the residents of the county; and

WHEREAS, the Board of Supervisors (the "Board") of Worth County, Iowa (the "County") by resolution previously established the Worth County Consolidated Urban Renewal Area (the "Urban Renewal Area") and adopted an urban renewal plan (the "Plan") for the governance of projects and initiatives to be undertaken therein; and

WHEREAS, a proposal has been made which shows the desirability of expanding the Urban Renewal Area to add and include all the property (the "Property") described on Exhibit A (on file at Auditor's Office) for; and

WHEREAS, the proposal demonstrates that sufficient need exists to warrant finding the Property to be an economic development area; and

WHEREAS, an amendment (the "Amendment") to the Plan has been prepared which (1) covers the addition of the Property to the Urban Renewal Area; and (2) authorizes the undertaking of new urban renewal projects in the Urban Renewal Area

consisting of (i) using tax increment financing to pay the costs of renovating and remodeling the existing County Courthouse and Jail or constructing a new County Courthouse and Jail; (ii) using tax increment financing to pay the costs of constructing county road and bridge improvements in order to enhance transportation infrastructure and encourage the promotion of economic development; and (iii) using tax increment financing to provide credit support to ReadiFuels-Iowa, LLC in connection with the installation of the pipeline from Hanlontown to Manly Terminal; and

WHEREAS, notice of a public hearing by the Board on the question of establishing the Property as part of the Urban Renewal Area and on the proposal to adopt the Amendment was heretofore given in strict compliance with the provisions of Chapter 403 of the Code of Iowa, and the Council has conducted said hearing on October 17, 2022; and

WHEREAS, the Planning and Zoning Commission of the County has reviewed and commented on the proposed Amendment; and

WHEREAS, copies of the Amendment, notice of public hearing and notice of a consultation meeting with respect to the urban renewal plan were mailed to the Northwood-Kensett Community School District, the Lake Mills Community School District, the St. Ansgar Community School District, the Central Springs Community School District and the City of Northwood; the consultation meeting was held on October 3, 2022; and responses to any comments or recommendations received following the consultation meeting were made as required by law; and

WHEREAS, portions of the Property lie within and within two miles of the incorporated limits of the Cities of Fertile, Iowa; Grafton, Iowa; Hanlontown, Iowa; Joice, Iowa; Kensett, Iowa; Manly, Iowa; and Northwood, Iowa (collectively known as the "Cities"), and pursuant to Section 403.17, the Cities have executed joint agreements (the "Joint Agreements") consenting to the County's proposed urban renewal activity on the Property; and

NOW, THEREFORE, It Is Resolved by the Board of Supervisors of Worth County, Iowa, as follows:

- Section 1. An economic development area as defined in Chapter 403 of the Code of Iowa is found to exist on the Property.
- Section 2. The Property is hereby declared to be an urban renewal area, in conformance with the requirements of Chapter 403 of the Code of Iowa, and is hereby designated the Worth County Consolidated Urban Renewal Area.
- Section 3. The development of the Property is necessary in the interest of the public health, safety or welfare of the residents of the County.
  - Section 4. It is hereby determined by this Board of Supervisors as follows:

The Amendment and the proposed projects and initiatives described therein conform to the general plan of the County as a whole;

Proposed projects described in the Amendment are necessary and appropriate to facilitate the proper growth and development of the County in accordance with sound planning standards and local community objectives.

C. It is not anticipated that any families will be displaced in connection with the County's undertakings under the Amendment. Should such issues arise, then the County will develop a feasible method of relocating any displaced persons into decent, safe and sanitary dwelling accommodations within their means and without undue hardship.

Section 5. The Amendment is made a part hereof and is hereby in all respects approved in the form presented to this Board, and the County is hereby authorized to undertake the projects and initiatives described therein. The Joint Agreements are hereby approved, and the Chairperson and County Auditor are hereby authorized and directed to execute said Joint Agreements on behalf of the County.

Section 6. All resolutions or parts thereof in conflict herewith are hereby repealed, to the extent of such conflict.
