## **RESOLUTION TO ADOPT RIGHT-TO-USE LEASE ASSET POLICY FOR WORTH COUNTY**

WHEREAS, the Governmental Accounting Standards Board (GASB) is in charge of creating and enforcing accounting standards; and

**WHEREAS**, GASB Statement No. 87, "Leases", requires a lessee to recognize a lease liability and an intangible right-to-use lease asset and recommends the establishment of a right-to-lease asset capitalization threshold policy;

**THEREFORE, IT IS HEREBY RESOLVED** the Worth County Right-To-Use Lease Asset Policy is approved by the Board of Supervisors. All right-to-use lease assets at or above \$50,000.00 must be reported. The threshold is to be consistently applied by all departments and offices of the County for financial reporting purposes and should overall capture most right-to-use lease contracts.
